1. No telephone bookings will be accepted. All bookings must be made by submitting the completed registration form to the Main Reception by hand, by fax to 6344 4476, email at events@sswimclub.org.sg or by mail to Katong PO Box 50, Singapore 914302.
2. Submission of this registration form is not proof of acceptance. Registration will be confirmed in writing to the member named above.
3. All billings will be debited to the member's account.
4. **Any cancellation must be stated in writing and submitted to the Social Department within 7 days upon registration.** No cancellation is allowed after 7 days after registration and 100% of the bazaar fee charge will be imposed for such cancellation.
5. The vendor may write-in for appeal to waive the 100% fee charge if after the 7 days grace period upon registration. However, the Management reserves all right to reject such appeal based on case to case basis.
6. The Club will not be held liable for any mishap or injury to, or any loss or damage by any participant during or a result of the event.
