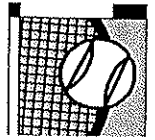


28TH TENNIS OPEN CHAMPIONSHIP

RULES AND REGULATIONS GOVERNING THE CHAMPIONSHIPS

1. The Championships shall be conducted under the Singapore Tennis Association and the International Lawn Tennis Federation Rules.
2. The Championships are open to all member of the SSC.
3. Format of play will depend on the number of entries received.
 - 3.1 One professional set of 9 games (tie-break at 8-all) will be played in the preliminary rounds and quarter-finals.
 - 3.2 In the semi-finals and finals, three sets (tie-break at 6-6) will be played. An interval, not exceeding 5 minutes, will be allowed between the second and third sets.
**Format of play will be subjected to changes depending on the number of participants.*
4. The competitor may not enter in the Doubles event without a definite partner and substitute will not be allowed after the draw of ties and fixtures have been finalized.
5. All ties will be played off at the SSC Tennis Courts according to the fixtures arranged by the Tennis Ad-Hoc Committee. The complete draw, ties, fixtures etc. will be posted on the Tennis Notice Board in the Club.
6. All competitors must be prepared to play their matches at the commencement of each section or when called upon, failing which they are liable to be scratched.
7. Postponements of ties will not be permitted unless it rains at the time of play. Any postponed tie shall be played before the next round involving any of the players.
8. Three Tennis balls will be supplied for each match. Players are to collect the balls from the Sports Assistant at the court before commencement of the match. Winner of the match shall be responsible for returning the balls and reporting the results to the Sports Assistant.
9. All ties will start at the specified times as scheduled in the fixtures with a grace period of (15) minutes given for each tie.
10. **Walk-over Rule:** A win or default (walk-over) will be awarded to a player if his/her opponent fails to turn up by the end of the grace period. In the event the Sports Department is informed that a player is conceding a walk-over, his/her opponent need not be physically present at the Tournament venue to claim the walk-over.
11. If both players fail to turn up for their scheduled tie, they shall both be scratched from the Championships.
12. Should there be any dispute, the player(s) concerned shall lodge an appeal to the Tennis Ad-Hoc Committee whose decision shall be final.
13. The Tennis Ad-Hoc Committee shall reserve the right to refuse entries without assigning any reason, to add to, or to alter the conditions and to seed the draw. Its decision on all matters shall be final.
14. Players should be properly attired according to the Bye-Laws of the Club. Track shoes and other types of shoes are not allowed.



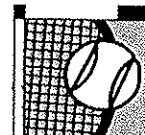
