## RULES AND REGULATIONS GOVERNING THE CHAMPIONSHIPS

1. The Championships shall be conducted under the Singapore Tennis Association and the International Lawn Tennis Federation Rules.
2. The Championships are open to all members of the Singapore Swimming Club.
3. Each competitor is limited to compete in up to two (2) categories only. Each category must have a minimum of five (5) entries before a schedule can be drawn. In the event of insufficient entries received, the Tennis Ad-Hoc Committee may scrap the category.
4. The competitor may not enter in the Doubles event without a definite partner and substitute will not be allowed after the draw of matches and fixtures have been finalized.
5. The Championships will be run in a "Knock-Out" format. All matches up to the Quarter-Finals will be played to one professional set of 9 games (8-8 tie-break). In the Semi-Finals and Finals, best of 3 sets (6-6 tie-break) will be played. An interval, not exceeding 5 minutes, will be allowed between the 2nd and 3rd sets. The "**No-Ad Scoring System**" will be implemented in this Championship. \* *Format of play subject to change depending on the number of entries received upon closing date.*
6. All match schedules **will NOT** be mailed out. Instead, it will be uploaded on SSC website [ [www.sswimclub.org.sg](http://www.sswimclub.org.sg) ], posted at the Club's Tennis Notice Board and emailed to your email address provided on your entry form. It is the competitors' responsibility to check their schedule of play 1 day before the start of tournament.
7. Umpires and Linesmen will not be provided throughout the Championships. Calls are to be made by the competitors on their respective courts.
8. **Walk-Over:** All matches will start at the specified times as scheduled in the fixtures with a grace period of (15) minutes given for late-comers. A walk-over would be deemed to have been conceded by any competitor who is not present on the courts when called upon to play after the grace period. In the event that the organiser is informed that a competitor is conceding a walk-over, his / her opponent need not be physically present at the Championships venue to claim his / her walk-over. Should both competitors fail to turn up, they shall both be scratched from the Championships.
9. **Warm up:** Strictly 10 minutes only.
10. Postponement of matches will not be permitted except for inclement of weather at time of play. Any postponed match shall be played before the next round involving any of the competitors.
11. **Tennis Balls & Scores Submission:** Three (3) tennis balls will be supplied for each match. Competitors are to collect the balls from the Sports Assistant at the tennis court (outside court no.1) before commencement of the match. Winner of the match shall be responsible for returning the balls and reporting the results to the Sports Assistant at Sports Office (2nd level of Sports Centre).
12. Should there be any dispute; the competitor(s) concerned shall lodge an appeal to the Tennis Ad-Hoc Committee whose decision shall be final. The Tennis Ad-Hoc Committee shall reserve the right to refuse entries without assigning any reason, to add to, or to alter the conditions and to seed the draw. Its decision on all matters on this Championship shall be final.
13. Competitors should be properly attired according to the Bye-Laws of the Club. Appropriate sports attire (Shorts and T-shirts) must be worn (Singlets are not considered appropriate attire). Only tennis shoes with rubber soles and heels (non-marking) would be allowed during play.
14. All competitors are invited to attend the Prize Presentation Ceremony cum lunch to be held on Sunday, 2 September 2018 immediately after the Finals at the Sports Centre's Viewing Gallery (approximately 1.00pm).
