RULES AND REGULATIONS GOVERNING THE CHAMPIONSHIP

- 1 Championships shall be conducted under the present rules of the game as established by the International Badminton Federation and the Singapore Badminton Association.
- 2 The Championship is open to amateurs who must be members of the SSC Club.
- 3 **All entry forms must reach Sports Department not later than**
- 4 All matches will be played based on best of **three games of 21 points**. An interval not exceeding five (5) minutes will be allowed between the second and third games of all matches.
- 5 A competitor may not enter in the Doubles events without a definite partner and substitutes will only be allowed at the discretion of the Tournament Committee and only on very exceptional circumstances.
- 6 All matches will be played in accordance with the schedule of play at the SSC Badminton Hall. The complete ties, fixtures, etc. will be posted on the Badminton Notice Board at the Club. Postponement of any matches will be at the Badminton Ad-Hoc Committee's discretion.
- 7 All competitors must be prepared to play their match at the commencement of each session or when called upon, failing which they are liable to be scratched. They must also act as linesman when called upon.
- 8 Postponement of matches shall be considered, unless both parties agreed on a rescheduled date within the tournament schedule.
- 9 **Walk-Over Rule:** A Win or default (walk-over) will be awarded to a player if his/her opponents fail to turn up by the end of the grace period of 15 minutes. In the event the Sports Department is informed that a player is conceding a walk-over, his/her opponent need not be physically present at the Tournament venue to claim the walk-over.
- 10 **Indemnity:** While reasonable precautions will be taken, the Singapore Swimming Club, its servants and Committee Members will not be responsible or in any way liable for any death, disability, personal injury, loss of property or any other loss howsoever arising from any cause whatsoever at any time during the course of this tournament.
- 11 All shuttlecocks for the games will be provided by the organizer. A change of shuttle during play will be permitted only if the Umpire is fully satisfied that a change is necessary. The Umpire has the right to refuse a change of shuttle even if both players agree to it. Any player found deliberately tampering with the shuttle when a change is refused may be disqualified if the Referee upholds the Umpire's decision.
- 12 The Organizing Committee reserves the right to interpret or amend the rules and regulations of the tournament at any time and its decision on all matters shall be final and binding. Notifications of such changes will be posted on the SSC Badminton Hall Notice Board. All participants are advised to visit the SSC Badminton Hall Notice Board frequently for any notices or changes to draws or schedules.
